Your Auditors having in accordance with instructions received from the Committee examined the Treasurers Accounts and Mr Bourne's claim for Rent; have the honor to state that independently of the interest soon due upon the Mortgage Money, the Institution is at present indebted £195.18 including the Rent of the House in Bowke Street amounting to £157.12.8 still due by the Institution.

In examining the Accounts it is found that a considerable sum has already been paid for Law expenses and a further sum is still due; the great amount of which has caused surprise to one of your Auditors (D.G.M.W.) who was present at a Meeting of Committee some time back at which Mr McGrath stated that so long as parchment was to be procured his services should be rendered gratuitously to the Institution. If Mr McGrath offer be remembered by other Members then present; your Auditors think that Mr McGrath might be reminded of his promise.

Your Auditors cannot close this brief Report without stating that the Treasurers Accounts have been kept in the most clear and satisfactory manner.

(Separate paper) With regard to Mr Bourne's claim for Rent I find that Capt. Cain's draft as his Agent on Mr Stephen for the sum of £161.11.8 including 3 Months Interest has been accepted in full liquidation of outstanding Rent of house in Bowke Street, but that the Institution will be indebted to Mr Stephen in that sum.

3. Every member on receiving a Book shall give a receipt for the same in a book kept for that purpose.
4. Any member shall be entitled to borrow not more than 3 Books at one time which he shall be required to return at the expiration of seven days unless the time may upon special application be extended.
5. Any member damaging or losing any Book will be required to replace the same, or belonging to a set will be held responsible for the repurchase of the Work.

Dr Greaves presented the report of the Sub-Committee on the present condition and future prospects of the Institution  
(Report as follows)

Melbourne Mechanics Institution  
August 12<sup>th</sup> 1843.

The sub-committee appointed by the Committee of Management Thursday July 13<sup>th</sup> to enquire and report as to the present circumstances and prospects of the Institution with instructions to ascertain the causes of the falling off in the number of subscribers and to suggest any measures for the advancement of the interests of the Institution

have examined into these matters accordingly and have to report. -  
The affairs of the Institution are in a very unsatisfactory condition as will appear by the statement of the Treasurer hereunto appended: by which it will be seen that the Institution is burthened not only with a mortgage of £1250 but a further debt of about £400 to meet the interest and pay the principal of which the annual income cannot be estimated at more than £300; of which the sub-committee regret to find that only about £25 or £30 is derived from subscribers

The sub-committee have taken much pains to ascertain the cause of this alarming decrease in the number of the subscribers and have reason to believe that several causes have operated to this effect. - The sub-committee are aware of that in reciting causes which may be considered to impugn the Committee of Management that they are in effect blaming themselves; but the sub-committee consider their duty to be simply to find the causes of the declension of subscribers; not the justice or injustice of those causes.

By personal observation and enquiry; by the report of the collector hereunto appended, and other sources; the Committee have reason to believe that the first cause of the declining of Members is the insufficiency of the Institution for the purposes for which it was originally intended. There is no museum deserving the name; the Library is very limited and until recently was almost entirely unavailable to the Members; there is no Reading Room, and there are no classes. Thirteen lectures indeed have been given since the formation of the Institution on various subjects and the expenditure during the same period has been exclusive of the Building, upwards of £1000.

A second cause of the falling off in the number of the subscribers is the depression of the times which there is no doubt have operated very extensively.

A Third Reason assignable is an opinion that no Salaried officer of the Institution should be a political partizan - that the time of the Secretary should not be so much taken up by other

- I Inability from want of means
- II Mismanagement of the affairs of the Institution in General with out specifying any direct charge against any individual
- III A Refusal to aid the Institution so long as the present Secretary holds office.

The collector begs to state that he considers a further call upon the subscribers, under existing circumstances as perfectly useless

avocations as to interfere with his duties to the Institution; together with personal objections to the present secretary upon grounds into which the sub-committee refrain from entering; but which being in existence, unquestionably prevent the support of man.

With respect to measures for advancing the interests of the Institution the sub-committee have but few to offer and with pain have to acknowledge that they are by no means very sanguine of great or quick improvement from any measure which may now be taken. They suggest the propriety of seeking assistance from the Government as one resource. - Economy in every department of expenditure especially in printing and advertising. - They further recommend the immediate opening of a Reading Room, which by erecting a small kitchen at the back of the premises, could easily be arranged, and further that the offices of Librarian and Secretary be combined; and that measures be taken for the safety of the Books both in the Library and when lent out to subscribers.

They also suggest the advantage of collecting the subscriptions in quarterly payments and of canvassing the public to support the Institution. Lastly the Committee recommend various measures to be taken for the regular delivery of lectures and the Establishment of classes; and that the public be solicited to add to the museum either by way of gift or loan interesting specimens of Art or Natural History.

The sub-committee have only to repeat their fear that the very depressed condition of the Institution; the dissatisfaction or apathy of the public and the Commercial distress now prevalent prevent them from entertaining very sanguine hope of great or immediate amendment; still however they feel confident that if the public see proper steps taken to fulfill the objects for which the Institution was formed, that the friends of science would rally round the Institution and the public would soon afford support in promoting its high and laudable objects.

Dear Sir

With reference to our conversation a few days ago on the state and prospects of our Institution, I think the view is exceedingly gloomy, and chiefly from the low state of our finances. The number who have adhered to us, under the practical proof of paying up their subscriptions is so small (being I believe under thirty, including the Committee of Management) that it appears almost impossible to carry on the Institution. We derive a considerable income from the Corporation, and one or two other bodies; but almost all of this has been specially set aside, to pay the annual charge of £150. 5s the interest of the £1250. that has been borrowed upon the Building. There is little beyond this to be depended on for the payment of expenses, and the Institution is still burdened with a balance of debt of about £400. - I am
