Letter from Mr. Guillaume of London, requesting a remittance

London Sep. 24. 1861.

Sir

I regret exceedingly that you should not have received the Times for Apr. 11-19. I cannot understand how it is that parcels of papers miscarry, they must be stolen in transit or at Melbourne, every paper is entered and checked before postage, and if only one were missing it would be forwarded by next mail.

Of course as it was through a mis-direction you lost the paper instead of the Chamber of Commerce, I must allow the fairness of your deducting the value. It was most unfair of them to open your parcel and abstract your papers. I have received a B. of Exchange for £30 reducing my a/c to £70-2-2. I will deduct the (2/2) two shillings and two pence. There were two suncoys in the eight days you mention. I am in very great want of money, my outstanding debts in Melbourne alone amounting to over £2,000 might I request your best endeavours to send me this sum £70. by the return mail if not already sent. and by doing so you would greatly oblige

Osborne in Trust for the Institution. Osborne or subsequent Trustees have at various times alienated the whole of the Land so purchased as delineated on the plan among the monuments of Little belonging to the Institution save as therein appears

As to Allotment No 3 of Section 11 we have already

reported to you.

The Grant of Allotment No 2. Section 11 was made in the month of Jan 7. 1841. to Osborne, who in April of the same year sold to one Smart Lots 12 to 16 inclusive together with the rights of way subtending these Lots as marked in the said plan ~~as~~ that owners and occupiers of other Lots in the section have no rights over these ways to the extent of that sale. The search is silent as to whether the Trustees have or have not alienated any other portions of these woods save as is hereinafter mentioned

In the year 1842 Osborne conveyed to Mr. Fear and others the whole of the land contained in the Grant inclusive of that previously alienated to Smart.

This peculiarity is not in any way explained by the papers.

In March 1843 the Trustees of the Institution conveyed to one Dawson and others, firstly all those Lots Nos 4. 5. 6. of Allotment No 2. Section No. 11 together with the rights of way of 10 feet wide and secondly Lot No. 7. of said allotment No. 2. The dimensions of this Lot being 25 ft. north and south by 50 ft. east and West, that part of the right of way therefore of 24 ft wide subtending it is still in the Trustees and they or any other person having a right of way over the present encroachment either as owners or occupiers of any portion of the respective allotment 2 or 3. can maintain an action against Mr. Miller for trespass on the case if brought within a period of 15 years from the time when the right of action first accrued.
