REPORT OF THE COMMITTEE

OF THE

MELBOURNE ATHENÆUM,

FOR THE YEAR 1938.

To be submitted to the Members at the General Meeting, on Wednesday, January 25, 1939, at 8 p.m.

THE Committee of the Melbourne Athenæum submits its report of the transactions of the year 1938, which is the ninety-ninth since the foundation of the Institution.

CENTENARY OF THE INSTITUTION.

The year 1939 will mark the Centenary of the Institution, and your Committee will take steps to make due celebration of this important occasion.

The Institution dates its history back to February 14, 1839, when a Union Benefit Society was established in Melbourne. On October 4, 1839, a few master builders connected with the Union decided:

"That a Mechanics' Institution be formed in Melbourne for the promotion of Science in this rising Colony, particularly amongst the young as well as the operative classes, and that a public meeting for the formation of such an Institution be held in the new Scots Schoolroom on the first Tuesday evening in November, at 7 o'clock, when all persons friendly to such an object are respectfully invited to attend."

The meeting was held on November 5, 1839, and the business was postponed for a week. The Melbourne Mechanics' Institution was formally established on November 12, 1839. The name of the Institution was changed to The Melbourne Athenæum in 1873.

The Finance Committee, Messrs. C. P. Rigg (Chairman), Masters, Grut, Wigg, W. J. Roberts, Kelly, Burr, C. R. Rigg, Burke, Bainbridge, and the President; the Library Committee, Messrs. Fielding (Chairman), Biggs, Gates, G. H. Roberts, Hunt, Robinson, Tredinnick, the President and Treasurer; the House Committee, Major Bolton (Chairman), Messrs. Hunt, Tredinnick, the Very Rev. D. A. Cameron, and the Treasurer; the Lecture Committee, Messrs. Biggs (Chairman), Grut, Hunt, Kelly, Rev. Dr. A. Law, the President and the Treasurer, held the usual meetings, and thus attended regularly to the various departments of The Institution.

Your Committee reports with regret the retirement of Mr. A. J. Masters, owing to ill-health. Mr. Masters, who was elected to the Committee in October, 1909, has been a most valued member. His expert knowledge on insurance has been of the utmost service to The Institution, which has benefited greatly by his experience.

The Immediate Past President, the Rev. Dr. A. Law, resigned on August 13.

The President, Vice-President, Treasurer and the following members of the General Committee, who are eligible for re-election, retire from office by effluxion of time:—Messrs. G. H. Roberts, Gates, Hunt, W. J. Roberts, Kelly, Tredinnick, and the Very Rev. D. A. Cameron.

The retirement of Mr. A. J. Masters also caused a vacancy.

FINANCIAL.

The statement of accounts is again shown in columnar form, under the headings of Building and Library. The main object of this is to enable members to realise the value of the service they receive.

The gross receipts from all sources amounted to £7,296/12/6, an increase of £82/5/11 on the amount received in 1937 (£7,114/6/7). The amount received in subscriptions—£2,675/3/6—is the highest recorded since 1935.

The gross expenditure amounted to £7,234/4/6, an increase of £354/0/9 on the figures for 1937 (£6,880/3/9). The increase in expenditure is mainly accounted for by the extra cost of books, magazines and newspapers (£97/3/8), improvements (£72/5/5), salaries and wages (£100/10/-) and repairs (£111/19/5).

Commencing the year with a credit balance of £324/11/6, there was a credit balance at December 31, 1938, of £386/19/6.

The Building Account is credited with all rents received. It has charged against it Interest (£457/5/11), Rates and Taxes (£809/0/9), Improvements (£72/5/5) and Architect's Fees (£11/8/6). In the other items the charges are divided between the Building and Library Accounts in proportion to the services rendered.

The Library Account is credited with the amount received from subscriptions (£2,675/3/6) and sales (£150/7/3). The main charges against the Library are Books, Magazines and Newspapers (£1,714/12/8), Exchange and Bank Charges (£338/0/6), and Salaries and Wages (proportion, £1,657/15/-).

It will be seen from the statement that the Building Account shows a surplus of £1,717/19/11, and the Library Account shows a deficiency of £1,655/11/11.

THE LIBRARY.

The popularity of the Library and Reading Room has been more than sustained, the amount received in subscriptions being the highest since 1935. The work of reclassifying and rearranging the Library has been completed, with satisfactory results, the comfortable working of The Institution being thereby accentuated. Alterations in the methods of binding have added to the brightness of the shelves, and members generally have expressed their appreciation of the service provided.

The supply of books, magazines and newspapers has been well maintained. Owing to a general increase in the price of works of fiction and the fact that many of the "best sellers" of the year were particularly expensive, a larger sum than usual has been expended, the benefit of members being the first consideration of your Committee.

The attention of members is directed to the urgent necessity for the prompt return of books borrowed, particularly those most in demand. If members would be punctilious in returning books as quickly as possible, the smooth working of the Library would be largely enhanced. Your Committee asks for the co-operation of members in this direction and is

confident that, now that attention has been specially directed to this matter, there will be an all-round improvement.

The competition of libraries in the suburbs and in city commercial houses is still strong and has to be seriously combated. The facilities provided in the Library in its lending and reference branches, and in the Reading Room, are unsurpassed. The privilege of having the Library and Reading Room open from 9 a.m. to 10 p.m. daily, including Saturdays and on all public holidays, except Christmas Day, Good Friday and Anzac Day—which is not available elsewhere—should be, and is, particularly appreciated by members living in the city and the nearer suburbs.

Your Committee feels that the advantages provided by the Library should be more widely known, and it urges members to do all in their power to enlist new members. The quarterly lists of books added to the Library provide much information, and members are invited to distribute these among their friends.

LIBRARIAN.

Mr. De Pledge, who was appointed Librarian on March 11, 1921, was granted leave of absence, after 17 years' valuable service, for three months on full pay, on account of ill-health. Your Committee is pleased to report that Mr. De Pledge's sea trip to the East completely set him up in health and that he resumed duty at the end of September, 1938.

Mr. B. Toman, the Assistant Librarian, was appointed Acting Librarian during Mr. De Pledge's absence and carried out his duties to the satisfaction of the General Committee, who voted him an honorarium of £10/10/- for special services rendered.

HONORARY MEMBERSHIP.

Your Committee, during the year, passed a regulation under Rule 30 for the satisfactory working of Rule 10, as follows:—

"That in all appointments of honorary members notice of the nomination should be given at one meeting of the General Committee and discussed and awarded at the next, such notice to be included in the business paper."

In recognition of his services to The Institution, Mr. J. A. Pietzcker was elected an honorary member under Rule 10.

Mr. A. F. French, who had been a member of The Institution, resigned on March 11, 1938, and your Committee, in view of his membership of 57 years and in accepting the resignation, invited Mr. French to use the Reading Room whenever he wished.

ART GALLERY.

The Art Gallery still retains its position as the best in Melbourne. During the year many notable exhibitions were held, and the crowds of visitors attending the various exhibitions were larger than in any previous year.

The 1938 season was opened by a combined exhibition organised by Mr. L. Gill. Other exhibitions were "The Herald" Australian Competition, Sir Arthur Streeton, Messrs. John S. Loxton, Joseph Kovesy (Hungarian artists), F. R. Thompson, Arnold Shore, Suhr and Miller, John

Gardner and John Rowell, A. D. and Amalie Colquhoun, Misses Gates and Holgate, Grace Gardiner, Dorothy Whitehead, Group 12, New Melbourne Art Club, Twenty Melbourne Painters and the Melbourne Society of Women Painters. Two notable exhibitions concluded the season: "Child Art from Many Countries," arranged by Mrs. A. P. Derham (Lecturer in Art to the Kindergarten Training College), and "Juvenile Art," organised by "The Herald."

Your Committee, at the request of Mr. John Rowell, has granted the use of the Art Gallery, free of charge, for an exhibition and auction sale of pictures in aid of the Bush Fire Relief Fund.

LECTURES.

During the year a series of seven lectures was arranged and met with success. A pleasing feature was the attendance of parties of boys and girls from the secondary schools.

"The Story of British Colonisation," by Professor R. M. Crawford, Professor of History, Melbourne University. (Chairman, Mr. W. H. Tredinnick.)

"C. J. Dennis: The Poet and the Man," by Mr. J. McRae. (Chairman, Mr. W. J. Roberts.)

"The Magic of the Jungfrau," by Mr. J. A. Pietzcker. (Chairman, the President.)

PLAY-READING SOCIETY.

The Athenæum Play-Reading Society, established in 1932 under the title of The Athenæum Dramatic Society, found, during the year, that it could not carry on. A deputation

be expected.

Your President was in the chair, and, after urging those present to show their interest in the Society by supporting it, handed the conduct of the meeting over to the Chairman of the Society, Mr. A. Wolskel.

At the conclusion of the programme, which was well received, Mr. Wolskel and Mr. L. V. Biggs, on behalf of your Committee, invited those present to express their willingness to support the Society. To this invitation there was practically no response.

The Play-Reading Society, after considering the position, decided "to recommend to its members that the present organisation be disbanded, with a view to enabling the Athenæum Committee to take such steps as it deems desirable to form an entirely new society, with new personnel and methods."

Your Committee expressed its sympathy "with the formation of any organisation which will increase interest and assist in carrying out the objects of The Institution," and deferred further action until such time as the general body of members could express "an opinion on the subject of a play-reading and/or literary society."

The Society thereupon terminated its activities and passed over to The Institution the sum of £2/9/9, the amount of its funds in hand.

Your Committee decided that this amount be held in trust for any similar effort.

RENOVATIONS AND IMPROVEMENTS.

During the year Frank Talbot Pty. Ltd., in accordance with the provisions of their lease, thoroughly renovated all the demised premises and also, with the consent of your Committee, installed new Neon electric signs over the main entrance.

During the year the whole of the premises occupied by The Institution received special attention and renovation.

In order to add to the comfort of members and to provide adequate heating to the Library and Reading Room, a new gas heating service was installed, at a cost of £72/5/5. This worked satisfactorily and is more economical than the former system.
