President's Report



It was a privilege to serve as President during the Melbourne Athenaeum's 185th anniversary year.

As the owners of a significant heritage building with a rich history as Melbourne's oldest cultural institution, we were delighted to welcome our patron, the Governor of Victoria, Her Excellency Professor the Honourable Margaret Gardner AC, to join us for afternoon tea in November to commemorate the 185th anniversary.

We have been fortunate to have the support of the Governor across our history dating back to 1839 when our first patron was Charles La Trobe, Lieutenant-Governor of Victoria.

To commemorate the anniversary, a new history overview was produced and a series of visual publications covering the theatres, library, museum, and gallery are being published.

We were pleased to see continued growth in membership. At the end of year, we had almost 1000 members who, in addition to our extensive library collection, enjoyed a range of benefits including music performances, play readings, authors' talks and artists' workshops.

Approximately 960 members and guests attended Friday night concerts and participation in Rare Book Week and Open House Melbourne were also popular. Visual artists Marco Luccio and Alissa Duke and playwrights Ash Flanders and Emilie Collyer were supported through the cultural program.

After the passing of our long-serving President Don Smith, a concert featuring bands he brought to the library was held to recognise his amazing contribution to the Ath. Don was instrumental in ensuring our financial stability while also starting the successful music program. A memorial service was also held in the library for our inaugural archivist Marjorie Dalvean. Marjorie, supported by volunteers, set up the physical and digital archive.

The Melbourne Athenaeum continues to be in a sound financial position, and I would like to thank Treasurer Kevin Quigley whose extensive knowledge of the Ath has been acquired over more than 50 years involvement. Kevin also plays a key role in the music program.

Revenue from our tenant leases is crucial to being able to maintain our significant heritage building. It is challenging to manage a heritage building while meeting contemporary standards. The priority in the coming year will be to undertake major repair works as well as various facilities upgrades. It will come as no surprise that insurance will continue to be a major cost.

I would like to thank my fellow management committee members for their contribution, our wonderful library staff led by Fiona Malcolm, our archivist Fiona Moore and our volunteers. A special thanks to Business Manager Sophie Arnold whose contribution was invaluable. Sophie has an extensive knowledge of the building and what is required to manage an institution as important as the Melbourne Athenaeum. I am therefore very pleased that Sophie has nominated for the President's role and there is no doubt we could not find a more suitable person. We are also fortunate that Lawana Coulson, who for some time has been involved in marketing and communications for the Ath, will become Business Manager.

Under this leadership and direction I am sure we can look forward to the continuing success of the Melbourne Athenaeum.





Archives Report

Having now been in the role of Archives Manager at the Melbourne Athenaeum since the end of 2023, I have been able to get to know the Archive's holdings and discover its treasures.



Work is underway on cataloguing the Archive using the e-Hive collection management system (CMS). In tandem with the cataloguing, the digitisation of the collection is also proceeding. A dedicated photographic/digitisation area has been established with advice and assistance from the University of Melbourne's Digitisation Centre (which provided its services at no cost). The objective is for items from the Archives to be digitised and attached to their corresponding catalogue record in the CMS and published online via an Archives search function on the Melbourne Athenaeum website.

Since commencing in the role of Archives Manager I have reviewed gaps in the Archive's holdings and sought to acquire items that would enhance these areas. New additions to the Archive have included two hand-coloured engravings by Albert Charles Cooke – an interior view of the Athenaeum Hall, c. 1872 and an exterior of the Melbourne Athenaeum, 1885. A very early view of the institution when it was known as the Melbourne Mechanics' Institute and School of Arts by Arthur Wilmore was also purchased. Six exhibition catalogues of displays held at the Athenaeum Art Gallery were also acquired covering shows by acclaimed artists Harold Septimus Power, George Bell, E. Phillips Fox and Ethel Carrick Fox as well as Janet Cumbrae Stewart. The Archive was also extremely fortunate to be the recipient of two donations over the past year. This included a bound collection of Melbourne Athenaeum Theatre Programs dating from 1924 to 1928 as well as a program for the play *Oh Sir Henry*. The other donation was an exhibition catalogue from a display of works by Norma Bull held at the Athenaeum Art Gallery in 1952.

Interest in the Archive also continues to grow, with 35 research requests processed over the last 12 months. These requests were received from other institutions including the National Gallery of Australia, academics, historians, private individuals both locally and overseas as well as members. Tours of the Archives were also given to staff from the National Library of Korea, Freemasons Victoria, the National Gallery of Victoria and the University of Melbourne.

During the last year, I have sought to profile and promote the institution and the Archive. This has included writing regular posts about items from the collection as well as the people who have been associated with the Melbourne Athenaeum for publication through the institution's social media channels. I presented lectures at the Australian Heritage Festival, Senior Citizens Week and to members of the Melbourne branch of U3A. I was invited to join the Melbourne Collections Forum, a professional forum of members drawn from across the city's GLAM sector. I also represented the Melbourne Athenaeum at Government House for the Understanding Victoria History Series that explored key periods and themes in the development of Victoria.

Volunteers

Our longest-serving volunteer, Moyra McAllister, passed away on 17 February 2024. Moyra was a tech genius who implemented our Koha library management system in 2011 and helped look after it until 2024.

Committee of Management President Don Smith passed away on 23 February 2024. Don was a long-time member of the library, a keen reader and largely responsible for our popular contemporary music program. He also introduced book reviews into the AGM in 2023.



Former archivist Marjorie Dalvean (who knew more about the Ath than almost anyone) passed away on 30 August 2024. Marjorie turned our archives from items stuffed in cupboards into a physical and digital archival collection.

New volunteers Heather, Diane and Sam came on board in 2024, joining Dallas, Elizabeth, Lea, Lynne, Norma, Pat, Perry, Rhonda and Susan as valuable members of the library team.

Industry Placements

Paul Bonnici (Box Hill TAFE), Adam Burcher (Swinburne) and Kristan Simon (Swinburne) all completed their industry placements at the Ath. Their enthusiasm, willingness to learn, and view of the library was refreshing.

Partnerships

In 2024 we entered into a mutually-beneficial partnership with the Melbourne Haiku Society (Fringe Myrtles). We partnered on two events with them this year.

After a chance encounter with Melbourne City U3A at a Postcode 3000 event we started discussions with them about some joint ventures in 2025.

Seniors Festival

Over 100 people attended talks during Seniors Week on the library and archives.

Melbourne Rare Book Week

We hosted three talks as part of Rare Book Week, as well as the inaugural Gary Morgan Oration. Each talk was fully booked and over 280 people attended.

Open House Melbourne

Over 700 people visited us over the Open House Melbourne weekend and we gained several new members as a result.

Big Book Sale

We raised over \$1000 across the weekend of 17/18 August as we held a 'big book sale' in the building's foyer.

On offer were a huge number of duplicate books and DVDs that had been donated and could not be accommodated in the library.

Don Smith

Former Melbourne Athenaeum Incorporated President Don Smith first discovered the library while walking past one Saturday morning in 1993. Ever curious and on the lookout for unusual locations, Don ventured up the stairs and instantly fell in love with the library.

A regular visitor, Don got to know then-Librarian, Jill Bartholomeusz, who convinced him to join the management committee in May 2007. He then became President at the AGM in April 2012.

Don was a long way from being a traditional library member or a traditional Chair of a not-for-profit organisation but he was driven by a love of the library which never diminished.

As well as being a regular borrower of books - the more obscure and quirky fiction and crime fiction the better - Don's passion for contemporary music (again the more obscure and quirky the better!) found a welcome outlet in the library's music program. Don took great delight in making contact with musicians from around Australia and overseas and inviting them to play at the library - many that neither staff or members had ever heard of previously. Don would then MC with such enthusiasm that attendees couldn't help but be brought along for the ride. The musicians loved his passionate support and were always keen to return.

Don's irreverence, always-present smile and dedication will be incredibly sadly missed by staff, Committee members, musicians and the members who were lucky enough to know him.

Don passed away on 23 February after an illness.

Vale Moyra and Marjorie



Moyra McAllister

One of the Ath's longest serving and loved volunteers, Moyra McAllister, passed away on 17 February.

We were privileged to accept her family's request to hold Moyra's memorial at the library. The attendance of more than 130 people was testament to the respect and affection held for Moyra, who had a long and respected career in libraries.

An article about Moyra's career said she "invariably left each library in which she worked in better shape than she found it". And that is certainly true of her decades of service to our library.

At the Ath, Moyra was the driving force behind the implementation of the Koha cataloguing system still used in the library today. This was a massive undertaking with the catalogue of 30,000 items needing to be migrated to the new system. There was considerable trepidation when the new system went live but, under Moyra's calm guidance, it all went smoothly.

Moyra was then instrumental in the organisation of the Koha Oz user group, which fostered communication and collaboration between libraries using Koha. Moyra also volunteered to be part of our eSmart team to ensure that our digital presence was as safe as possible and that our members were informed about risks and protected online.

Moyra and husband Trevor were also familiar faces at most library events and Liam, one of Moyra and Trevor's grandsons, has worked at a few of those events.



Marjorie Dalvean

The life of our much-loved, long-time archives co-ordinator Marjorie Dalvean was celebrated at a memorial event in the library on Saturday 12 October.

Marjorie (11 October 1940 – 30 August 2024) first worked at the library as a junior assistant in the 1950s, before returning after retirement to volunteer.

At that time, there were no archives – just items stuffed under stairs and in cupboards, with no regard for their protection or preservation.

With the help of a team of volunteers, Marjorie set up a physical and digital archival collection that is worthy of research and intrinsic to the story of European settlement.

Marjorie encouraged research essays to be written and published, promoted the Athenaeum through talks and workshops, welcomed visitors and responded to thousands of inquiries ranging from family research to city planning.

Marjorie retired from the Ath in 2018, after many years of much-valued service.

Fortunately the Dalvean family's involvement with the Athenaeum continues, with daughter Jo now a member of the Committee of Management. Melbourne University's Professor Andrew May delivered the inaugural Gary Morgan Oration for Rare Books Melbourne at the library

During 2024, we were very happy to form partnerships with two much-loved and highly effective Melbourne cultural organisations.

After many years of hosting events during Melbourne Rare Book Week, we moved to formalise a partnership with organisers Rare Books Melbourne. In addition to hosting events during Rare Book Week each year, we now also host the Rare Book Week organising committee meetings and events such as the Gary Morgan Oration.

Program Director Professor Chris Browne said he was "delighted with the growing and ongoing partnership between Melbourne Rare Book Week and the Melbourne Athenaeum Library". "It seems absolutely right for our organisation, Rare Books Melbourne, to be closely linked to such an historic and important library in the cultural history of Melbourne, so that we can pursue our common interests in partnership."

We also formed a new collaboration with U3A Melbourne City, which will see our members and U3A members offered membership discounts, workshops and events.

Melbourne Athenaeum Library Manager Fiona Malcolm said: "We look forward to this partnership continuing beyond 2025 and are sure it will benefit members of both organisations."



1 Summary of Material Accounting Policy Information

(a) Basis of Preparation

This financial report is a special purpose financial statement prepared in order to satisfy the financial reporting requirements of the Australian Charities and Not-for-profits Commission Act 2012. The Committee has determined that the not-for-profit Association is not a reporting entity.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101 *Presentation of Financial Statements*, AASB 107 *Statement of Cash Flows*, AASB 108 *Accounting Policies*, *Changes in Accounting Estimates and Errors* and AASB 1054 *Australian Additional Disclosures*.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The functional and presentation currency of The Melbourne Athenaeum Inc. is Australian dollars. Comparatives are consistent with prior years, unless otherwise stated.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(b) Income Tax

The Association is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

(c) Revenue and Other Income

Interest revenue is recognised using the effective interest rate method.

Revenue from membership subscriptions is recognised on a cash basis

Investment property revenue is recognised as and when receivable under the terms of the lease agreements with the property tenants.

All revenue is stated net of the amount of goods and services tax (GST).

Grant revenue

Where grant income arises from an agreement which is enforceable and contains sufficiently specific performance obligations then the revenue is recognised when control of each performance obligation is satisfied.

Each performance obligation is considered to ensure that the revenue recognition reflects the transfer of control and within grant agreements there may be some performance obligations where control transfers at a point in time and others which have continuous transfer of control over the life of the contract.

Amounts arising from grants in the scope of AASB 1058 are recognised at the assets fair value when the asset is received. The Company considers whether there are any related liability or equity items associated with the asset which are recognised in accordance with the relevant accounting standard.

(c) Revenue and Other Income continued

Donations

Donations are allocated to the Public Fund Account, where they are held until the Public Fund Committee meets and approves their withdrawal for allocation to expenditure incurred.

Donations are held in deferred income until approval for withdrawal is received, after which, amount is receognised as revenue.

Other income

Other income is recognised on an accruals basis when the Association is entitled to it.

(d) Property, Plant and Equipment

Property

The land was purchased in 1842 and there have been no comparable sales in the immediate area for some time. In 2017 the Committee decided to value the land component of the Property to that calculated by the Tax Office for Land Tax purposes of \$3,060,000 resulting in a credit to the Asset Revaluation Reserve of \$3,060,000.

The building is a valuable heritage site and heavily protected by heritage orders. It is also subject to constant renovation and restoration. The replacement cost is difficult to determine so in 2017 the Committee decided to revalue it on the basis of its economic worth to The Melbourne Athenaeum, being a discounted calculation of actual and implied rentals for the next ten years. This resulted in a valuation of \$5,000,000 and a transfer to the Asset Revaluation Reserve of \$2,610,956.

Plant and Equipment

Plant and Equipment is carried at cost less depreciation over the useful life of the assets.

The Book Collection

In 2017 the Committee re-valued The Book Collection from the carrying value in 2016 of \$179,343 to \$300,000, resulting in a transfer to the revaluation reserve of \$120,657.

The valuation reflects the current replacement cost, based on the average purchase price of books discounted by 50% to reflect the average age of The Book Collection.

Depreciation

Plant and equipment, excluding freehold land, is depreciated on a straight-line basis over the asset's useful life to the Association, commencing when each asset is ready for use.

(e) Leases
